

IIFBC PARTNER AGREEMENT

(Promotions Through IIFBC's Learning Management System)

AGREEMENT

Purpose

1. International Institute of Faith Based Counseling (IIFBC) has been a school of ministry since 1997. Through the years IIFBC has maintained its integrity, fostered relationships with ministers, and graduated a significant number of students.
2. IIFBC currently offers its trainings via classroom instruction, zoom classes, and online through a learning management system. The learning management system automates the whole process including the enrollments, payments, presentation of materials, record keeping, exams, and certificates.
3. IIFBC has the means to offer to other ministers and ministries an opportunity to partner together and benefit from the years of work it took for IIFBC to build its platform. IIFBC has the staff, experience, online presence, and platform to help others reach a greater number of people through a mutually beneficial relationship. Basically, IIFBC can handle all the "backend" work while the PARTNER receives exposure and compensation for the ministry training materials without having to handle the administration or build the platform it takes to present those trainings.

Financial

1. Any compensation from IIFBC to the PARTNER will be to an organization or to an individual. If an individual, it will be as contract laborer through IIFBC's payroll company as a direct deposit. PARTNERS are responsible for their own taxes. A 1099 will be sent at year's end. A valid ID, social security number, and bank account information will be required to set up compensation through the payroll company.
2. PARTNER will receive 50% of the tuition/enrollment fees from the classes/workshops/trainings presented from IIFBC's Learning Management System. The materials needed to offer the classes/workshops/training will be supplied to the student through the Learning Management System as online media or a download to the student.

What IIFBC Will Provide:

1. Phone and email support regarding the conducting and presenting of approved PARTNER sponsored online classes, workshops, and trainings promoted from IIFBC Learning Management System.
2. Promoted by IIFBC through website, newsletters, email campaigns, and social media.
3. IIFBC will provide office administrative support for registration, enrollments, and enrollee questions.

4. The Learning Management System will keep records of graduates, contact info, courses completed, and test grades. Graduate certificates will be emailed to the graduates by the Learning Management System.

Administration of Offerings

1. Tuition rates for classes/workshops/trainings are decided by the PARTNER. Funds are collected by the Learning Management System. Any exceptions to marketed rates can be paid through IIFBC's Stripe account. The PARTNER will receive commission only from funds paid.
2. The PARTNER is responsible for submitting to IIFBC the documents/manuals/media/tests, etc. for the student to satisfactorily complete the course according to the PARTNER's standards.
3. The PARTNER offerings can be stand-alone courses or part of a program/bundle, which can be offered for a title of certification.

Liability and Disclaimer and Termination

1. IIFBC does not assume any legal liability or responsibility for the accuracy, completeness, or usefulness of any information, information within course manuals, or process disclosed. In no event shall IIFBC be liable for any compensatory, special, direct, incidental, indirect, consequential damages, exemplary damages or any damages whatsoever resulting from the use of or the loss of use from, profits lost, or results whether resulting from loss of use or performance of the information generally or on any other basis. If the limitation of liability or the exclusion of warranty set forth herein is held inapplicable or unenforceable for any reason, then IIFBC's maximum liability for any type of damages shall be limited to U.S. \$100.00 (one hundred dollars).

You agree to protect, defend, indemnify and hold IIFBC, its directors, officers, employees, agents, parent corporation, subsidiaries, affiliated corporations, and divisions harmless from all claims, proceedings, damages, actions, profits, liabilities, judgments, penalties, liens, forfeitures, fines, costs, expenses, attorney's fees, and costs of settlement, and other losses, consequently, directly or indirectly involving you, incurred as a result of, arising out of, or connected with being a PARTNER with or for IIFBC.

In no event shall Life Training Institute (LTI) dba IIFBC be liable to you for any damages, direct or indirect, including any lost profits, lost savings, interruption of business, loss of business opportunities or other incidental or consequential damages, arising out lack of interest in PARTNER's offerings or technical malfunctions of the Learning Management System.
4. **This Agreement may be terminated at any time for any reason by IIFBC or PARTNER with a 30-day written notice.**
5. The terms and conditions of this Agreement shall be governed and construed by the laws of the State of Texas, without giving effect to its conflict of laws provisions. You agree to submit to the jurisdiction of the State of Texas, Hardin County for any and all disputes, claims, and actions arising from or in connection with this Agreement.
